SEND GREETINGS:

WHEREAS, *we*, the said *J. E. Greer and Callie S. Greer*

in and by *we* certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *One Thousand and 150* Dollars,
