SEND GREETINGS:

WHEREAS, *we*, the said *J. F. Armstrong and Annie May Armstrong*

in and by *Our* certain promissory note in writing, of even date with these presents *are* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Seven hundred fifty and ¹⁰/₁₀₀* Dollars,

Greenville Township, being lot no. 144 according to a plat recorded in Plat Book A Page 460, R. M. C. J. Office for Greenville County - Beginning 70 feet from the corner of M^c Wade Avenue and "New cut" road; thence with M^c Wade Avenue northerly 50 feet to corner of lot no. 143; thence westerly 150 feet to 10 foot alley; thence southerly with said alley 50 feet to corner of lot no. 145; thence easterly 150 feet to the beginning corner.
