We, *Mary A. Walden and Ellie Walden*

SEND GREETINGS:

WHEREAS, We, the said *Mary A. Walden and Ellie Walden*

in and by *our* certain promissory note in writing, of even date with these presents *are* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *One Thousand and no/100* Dollars,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *us*, the said *Mary A. Walden and Ellie Walden*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

Greenville Township, being lot in Ward Five of the City of Greenville, and having the following metes and bounds, as shown by plat of the A. J. Mills property recorded in Plat Book C, page 223, beginning at a point 125 feet from the southwest intersection of Memminger Street and Alington Avenue, and running thence along Memminger Street S. 16-15 N. 60 feet to a point common corner of lots 8 and 9, thence N. 73-45 W. 157 feet to a point on a 15-foot alley; thence N. 73-45 E. 157 feet to the beginning corner, being known and designated as Lot No 8 on said plat.
