WHEREAS, *I*, the said *R. L. Meares*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Forty-nine Hundred + no/100* Dollars, to be paid on or before the date when the *32* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I* fail to pay said interest or comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto, had, will more fully appear.

*on the South side of Tindal Avenue in the Sixth Ward of the City of Greenville, and designated as Lot No. 40 of Block B. of Cagle Park as shown on plat recorded in Plat Book "C" page 228 and more particularly described as follows:*  
*Beginning at an iron pipe on the South side of Tindal Avenue, corner of Lot No. 39; thence with line of Lot No. 39 S. 12.31 E. 152 feet to an iron pipe on line of Lot No. 8; thence with line of Lot No. 8 S. 89.07 W. 117.50 feet to an iron pipe, corner of Lots Nos. 7 and 8; thence with line of Lot No. 7 S. 73.01 W. 26 feet to an iron pipe corner of Lot No. 41 N. 16.41 W. 155.50 feet to an iron pipe on Tindal Avenue; thence with said Avenue N. 83-07 E. 61 feet to the beginning corner.
