WHEREAS, *I*, the said *H. H. Davis*

*Near the Laurens Road, East of the City of Greenville, designated as lot no 57 in subdivision of *100* lots as shown by plat recorded in Plat Book F, page 42, having the following meters and bounds, to-wit:*

Beginning at an iron pin corner of Beachwood Avenue and Zara Streets, and running thence with Beachwood Avenue 60.5 feet to corner of lot no 58; thence with line of lot no 58, 153.5 feet to line of lot no 56; thence S. 25-30 E. 60 feet to Zara Street; thence with Zara Street N. 64 30 W. 161.8 feet to the beginning.
