WHEREAS, *we*, the said *J. F. Berry and W. C. Berry*

in and by *our* certain promissory note in writing, of even date with these presents, *are* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Thirteen Hundred Fifty + 00/100* Dollars,
