WHEREAS, I, the said Mary E. Norris

in and by me certain promissory note in writing, of even date with these presents, am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Four Thousand & No/100 Dollars,

and being the South side of West Park Avenue (formerly Carrier Street), and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Park Avenue 428 feet from Southwest corner of Townes Street and Park Avenue, and running thence with said Park Avenue, N. 78-30 W. 50 feet to center of driveway 10 feet wide, which has been heretofore provided for in deed of Josie L.
