WHEREAS, *I*, the said *S. B. Jones*

in and by *my* certain promissory note in writing, of even date with these presents, *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Fifteen Hundred & no/100* Dollars,

to be paid on or before the date when the *3rd* Series of the Installment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I* fail to pay said interest or comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto, had, will more fully appear.

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina

Containing three acres, being the tract fronting on the White Horse Road and Franklin Road according to plat made by J. A. Hester, Surveyor, February 7, 1928, and more particularly described as follows:

Fronting on White Horse Road 6.70 chains and Franklin Road 5.68 chains; thence N. 38 W. 6.20 chains; thence S. 39 1/2 W. 2.48 chains, bounded by A. M. Jones and Bynum Estate, being a portion of the 12 acre tract conveyed to J. F. Williams by M. G. Jones by deed dated March 20, 1928, recorded in Vol 126, page 527, and this day conveyed to me by J. F. Williams, deed to be recorded.
