WHEREAS, *I*, the said *B. L. Hughes*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Nine Hundred no/100* Dollars,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

known as lot no. 27 on plat of *property of H. B. Bates*, recorded in Plat book F, page *25*, in *Grabing* the following metes and bounds:

Beginning at an iron pin on south side of Bates Street, corner of lot 25, and *beginning* thence S. 48-30 W. 150 feet to iron pin, joint corner lots 24, 27 and 25; thence along back line of lot 26, N. 55-40 W. 50 feet to iron pin, joint corner lots 29, 28, 26 and 27. thence along line of lot 29, N. 48-30 E. 150 feet to iron pin on south side of Bates Street; thence along Bates Street S. 55-40 E. 50 feet to beginning corner.
