I, *F. M. Altom*

SEND GREETINGS:

WHEREAS, *I*, the said *F. M. Altom*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Six Hundred 20/100* Dollars,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

on the northwest corner of O'Neal and Y. M. C. A. Streets in what is known as City View and being a part of the lot no. 21 as shown on plat recorded in plat book A, page 461, and having the following metes and bounds:

Beginning at a corner of said streets and running thence in a northerly direction with Y. M. C. A. street 50 feet to corner of lot no. 20; thence with line of lot 20 in a westerly direction 100 feet; thence in line parallel to Y. M. C. A. Street and in a southerly direction 50 feet to O'Neal Street; thence in an easterly direction and with O'Neal Street 100 feet to beginning.
