SEND GREETINGS:

WHEREAS, *I*, the said *H. J. Martin*

Martin in hand, well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

Greenville Township, all those two lots situate, lying and being on Green Street, as shown on plat of property of Mountain View Land Company recorded in the Office of the R. M. C. for Greenville County in Plat Book A, page 396 and 397, being known and designated as lots nos. 113 and 114; Beginning at a point on Green Street, joint corner of Lot no. 114 and 115, running thence with line of lot no. 115 S. 89 1/2 E. 113 feet to a 10 foot alley; thence with said Alley N. 11 1/2 E. 121 feet to corner of lot no. 113 and Green Street; thence with Green Street S. 35-25 W. 148 1/2 feet to point of beginning.
