In West Greenville, having the following metes and bounds to wit:
Beginning on the Northwest corner of Ruedett and Aiken Street and running thence with Ruedett Street N. 45.09 W. 92.7 feet to McCall's line; thence N. 43-53 E. 58 feet thence N. 24-33 E. 22.5 feet to an alley; thence with said alley S 22-22 E. 54.6 feet thence continuing with said alley S. 43-47 E. 50 feet to Aiken Street.
