WHEREAS, We, the said Trustees above mentioned

in and by Our certain promissory note in writing, of even date with these presents are well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Two Hundred & no/100 Dollars,
