WHEREAS, *We* the said *Trustees above mentioned*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *us* the said *Trustees above mentioned* in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

outside the corporate limits of the city of Greenville, known and designated as lot #21 in block 13 on plat of the lands of the Melville Land Company, recorded in the P. M. C. office for Greenville County in plat Book A, page 159, having a frontage on Burnett Street of 50 feet with a depth of 150 feet.
