TO HAVE AND TO HOLD, all and singular, the said Premises unto the said Agnes Mitchell, Agnes Mitchell Atty, and Susan Vaughan Heirs and Assigns, forever. And we do hereby bind ourselves, our Heirs, Executors and Administrators,

to warrant and forever defend, all and singular the said premises unto the said J. S. Allen, his Heirs and Assigns, from and against us and our Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.

And the said Mortgagor..... agree..... to insure the house and buildings on said lot in a sum not less than Three Hundred Dollars (in a company or companies satisfactory to the mortgagee.....), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said mortgagee....., and that in the event that the mortgagor..... shall at any time fail to do so, then the said mortgagee..... may cause the same to be insured in our name and reimburse himself for the premium and expenses of such insurance under this mortgage, with interest.
