WHEREAS, I, Sunnie M. McKinney

In Greenville Township, and having the following metes and bounds: Beginning at the intersection of Davis and McCall Streets, and running thence with said Davis Street S. 23-30 W. 126 feet to stake; thence N. 55-54 W. 60 feet to stake; thence N. 23-30 E. 126 feet to McCall Street; thence with said McCall Street S. 55-54 E. 60 feet to the beginning, being a part of lots nos 23 and 24 of Hans Spence Park.
