SEND GREETING:

WHEREAS, *I*, the said *H. E. Littlejohn*
in and by *my* certain *promissory* note in writing, of
even date with these presents, *and* well and truly indebted to

in the full and just sum of *Thirty Six Hundred and Fifty and ¹⁰⁰/₁₀₀* *(3650.00)*
Dollars, to be paid *on or before the 15th day of*
May A.D. 1929

with interest thereon, from *date* at the rate of *8* per cent. per annum to be
computed and paid *annually*

until paid in full, at interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage and not further providing for an attorney's fee of *seven* per cent on
whole besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant bar-

gain, sell and release unto the said *Mary McM. Bailey*, All that certain piece, parcel or lot of land situ-
ated, lying and being in Ward One of the City of Greenville, County of Greenville, State of
South Carolina, on the North side of West Earle Street, and being lot "J" of Map 6 of the
Mt. City Land and Improvement Company as shown on plat filed in Deed Book W.W., at page 605
of the records of the R.M.C. Office for Greenville County, and having the following metes
and Bounds, to-wit: Beginning at a stake, corner of Lot "I" of Map 6 and running thence with
Earle Street S. 84-¹/₂ E. 65-¹/₂ feet, more or less, to a stake, corner of lot "K"; thence with
line of lot "K", N. 5-¹/₂ E. 200 feet to a stake, corner of lot K and land of Stone; thence
with Stone line N. 84-¹/₂ W. 65-¹/₂ feet, more or less, to a stake, corner of lot "I"; thence
