*All that certain tract of land in Butler Town-  
ship, Greenville County, South Carolina, about  
four miles from Greepville Court House near  
Bloods Crossing, being Tract No. 1 of Amanda  
Poole land, and  
Beginning in the center of Lowndes Hill Road, at  
the corner of Robert Wickliffe land, thence with  
Wickliffe's line S. 45-25 E. 561 feet to corner of Tract  
No. 2; thence N. 34-40 E. 205.3 feet to center of a  
road; thence with road N. 55-20 W. 553 feet to  
Lowndes Hill Road; thence with Lowndes Hill  
Road 110 feet to the Beginning corner, being  
the same land whereon I now reside and a
