computed and paid annually

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal  
or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, Louis Sherfese  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant bar-  
gain, sell and release unto the said Thos. H. Pope, his heirs and assigns:

All that tract or lot of land in Greenville Township, Greenville County, State  
of South Carolina, and being more particularly described as follows\_ Beginning at the  
southeast corner of Lot No. 50 and running thence with Ridge Drive N. 185 feet to the  
joint corner of Lots No. 50 and 19; thence in a westerly direction 81 feet to the joint  
corner of Lots Nos. 50 and 20; thence in a southerly direction 183.7 feet to a point on  
Club Drive; thence in a easterly direction 83 feet along said Club Drive to the corner  
of beginning; and being Lot No. 50 according to plat of a survey of the Ables and Razor  
property made by Fitzpatrick-Terry Company, September 1919 and recorded in Plat Book  
"E", at page 153, R. M. C. Office for Greenville County.
