WHEREAS, I, *Lamie Bowling*, the said *Lamie Bowling*
in and by *my* certain *promissory* note, in writing, of
even date with these presents, *am* well and truly indebted to

V. M. Latt
in the full and just sum of *seventy-three and 29/100* (\$73.29)
Dollars, to be paid *one year after date*

with interest thereon, from *date* at the rate of *8* per cent. per annum to be
computed and paid *semi-annually*
until paid in full all interest not due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent*

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, *Lamie Bowling*, the said *Lamie Bowling*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *V. M. Latt*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *V. M. Latt*

This mortgage is satisfied in full
all that lot of land situate in the State and County aforesaid in Greenville Township, two miles from Greenville, about house, having the following metes and bounds, to-wit:

Beginning at an iron pin on south side of David Street at corner of lot of J. W. Campbell, and running thence with his line 190 feet to an iron pin on an alley; thence with the alley S. 41-30 E. 95 feet to an iron pin on corner of lot of J. L. C. Bates; thence with Bates's line N. 48-30 E. 190 feet to an iron pin on David Street; thence with David Street N. 41-30 E. 45 feet to the beginning corner, known as Lot # 74 of Hammett Lands, on a plat made by W. M. F. Lee, Surveyor, July 3, 1903. (Conveyed to me by W. F. Higgins by deed recorded in Volume S. S. S. page 420).

Less, however, a lot having a frontage of 47 1/2 feet on David Street, and running back in parallel lines a distance of 190 feet described in deed executed by me to M. L. Campbell and J. W. Campbell, recorded in Volume 97, page 256, reference to which is made.
