in consideration of the sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Peoples National Bank*

of *Greenville S.C.* all that tract or lot of land in *Greenville* Township, Greenville County, State of South Carolina.

*on the west side of Meadso Avenue, and being known and designated as lot # 84 (Eighty-four) of Glenn Grove Park, as shown by plat made by R. E.
