East, Engineer, May 1929, and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin in the Eastern line of East North Street, joint corner of lots Nos. 1 and 2 and running thence with East North Street, S. 41-02' N. 26 feet to an iron pin; thence still with East North Street, S. 21-57' N. 27.9 feet to iron pin in line of Lot No. 3; thence with the line of said Lot, S. 65-54' E. 206.8 feet to an iron pin; thence N. 17-09' E. 11.8 feet to an iron pin; thence N. 41-04' E. 34.1 feet to iron pin corner of Lot No. 1, thence with the line of that Lot, N. 49-02' W. 200.4 feet to the point of beginning, and being a portion of the land conveyed to the Grantor by C.
