in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid to and before the signing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Peoples National Bank, as Guardian for the minor children of St. St. Valentine* all that tract or lot of land in *which Springs* Township, Greenville County, State of South Carolina.

Near Paris and being known and designated as Tract no 2 of the Estate of G. A. Greene et al, as shown on a subdivision and plat of same, made by R. E. Dalton Engineer, in July 1924, and containing 68.50 acres, more or less, and having the following metes and bounds and courses and distances, as shown on said plat, to-wit:
