SEND GREETING:

Cooper*, in and by *May* certain *provisionally* note in writing, of even date with these presents, *11/22* well and truly indebted to *J. M. Wells and Nora W. Cooper, as Guardians* in the full and just sum of *Forty-four Hundred (\$4400.00)* Dollars, to be paid *at the rate of Five Hundred Dollars (\$500.00)* annually beginning one year from the date *11/22*.

with interest thereon, from *date* at the rate of *10% per annum* per cent. per annum to be computed and paid *quarterly* until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *the amount due* besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *Nora W. Cooper and J. M. Wells, as Guardians*,

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these presents do grant, bargain, sell and release unto the said *J. M. Wells and Nora W. Cooper as Guardians*,

their successors and assigns, *one* of that lot of land situate on the North side of East 26th Street, in the City and County of Greenville, S. C., fronting said Street 75 feet, with a depth of 62 1/4 feet, more or less, and being the land conveyed to *Nora W. Cooper* by *R. H. Johnson*.
