All that certain piece, parcel or lot of land with the buildings and improvements situate thereon, lying and being in Greenville Township, Greenville County, South Carolina, known and designated as Lot No. 16, Block A, on plat of property of Northgate, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "G", at pages 135-136, and having, according to a recent survey thereof made October 11, 1935, by Dalton & Neves, Engineers, the following metes and bounds, courses and distances, to wit:

Beginning at an iron pin on the North side of Parkside Drive at joint corner of Lots 16 and 17 on said plat, said point being 219.2 feet west from the northwest corner of the intersection of Parkside and Arcadia Drives, and running thence along the north side of Parkside Drive S. 72-55 W. 100 feet to an iron pin at corner of Lot 15, thence with the line of lot 15 N. 5-15 W. 135.5 feet to an iron pin corner of lot 14; thence with the line of lot 14 N. 59-00 E. 90 feet to an iron pin at rear corner of lot 17; thence with the line of lot 17 S. 12-00 E. 155.2 feet to the north side of Parkside Drive, the beginning corner.
