

Agreement of Extension of Loan No. 191797

Whereas, there now remains unpaid on a certain note executed and delivered by J. E. Stuckey, Jr., to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated October 29<sup>th</sup>, 1926, recorded in said County on October 30<sup>th</sup>, 1926, in volume 171 of mortgages, on page 38, the sum of Seventy-Five Hundred (\$750.00) Dollars, with interest from October 29, 1931, and,

Whereas, title to the mortgage premises is now vested in J. E. Stuckey, Jr., subject to said mortgage and,

Whereas, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

Now, Therefore, the said J. E. Stuckey, Jr., and Margery L. Stuckey (wife) hereby agree to pay the principal sum remaining due as appraised as follows:

- 250.00 on April 29<sup>th</sup>, 1932;      250.00 on October 29<sup>th</sup>, 1932;
  - 250.00 on April 29<sup>th</sup>, 1933;      250.00 on October 29<sup>th</sup>, 1933;
  - 250.00 on April 29<sup>th</sup>, 1934;      250.00 on October 29<sup>th</sup>, 1934;
  - 250.00 on April 29<sup>th</sup>, 1935;      250.00 on October 29<sup>th</sup>, 1935;
  - 250.01 on April 29<sup>th</sup>, 1936;      \$5,250.01 on October 29<sup>th</sup>, 1936;
- with interest from October 29<sup>th</sup>, 1931 to October 29<sup>th</sup>, 1936, at the rate of five and one-half per cent per annum, payable semi-annually; and with interest after maturity as set forth in said note.

Prepayment Privilege: Privilege is given to make additional payments on the principal sum of said note in sums of \$100.00, or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
