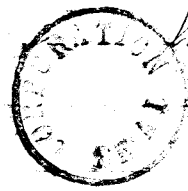

Norwood Property; thence with line of his property, a portion of which line runs through a brick wall N. 65 E. 59.4 feet to an iron pin in the eastern side of Norwood Place Street, which iron pin is 350.3 feet North of Washington Street; thence with Norwood Place Street, N. 24-30 E. 89.5 feet to the point of beginning.
