

driveway 18 feet wide; thence N. 51-15 W. 94 feet to a stake on line of property formerly belonging to the estate of F. M. Trimmier, deceased; thence N. 37-40 E. 277.8 feet with the line of said Trimmier property to a stake on the west side of Howard Street; and thence with Howard Street S. 51-15 E. 94 feet to the beginning corner; being bounded on the north by the Trimmier Estate, on the East by Howard Street, on the South by common driveway, and on the west by Spartan Mills; being the property upon which the substation is now established, all of which will more fully appear by map of W. N. Willis, C. E., dated November 7, 1923, and April 20, 1926; being the same property conveyed to Manufacturers' Power Company May 5, 1926, by Spartan Mills.

The above two lots of land are in all respects the same which were conveyed to the Wateree Power Company by the Broad River Power Company by deed dated July 29, 1927, and recorded in the office of the R. M. C. for Spartanburg County, S. C., in Book 7-H, pages 715 et seq., as First Lot and Eighth Lot.

Being the same property conveyed to the Company by deed of Wateree Power Company, dated June 12, 1929, duly recorded in the public registry of Spartanburg County, South Carolina, in Book 7-T, at page 224.

**PARCEL NO. 7.**

The following described electric distribution lines and system, franchises and other property, to-wit:

1. That franchise granted by the City of Spartanburg to the Manufacturers' Power Company February 10, 1919; and the distribution system in and about the City of Spartanburg.

2. The distribution system in and about the Town of Fair Forest and the Saxon and Arcadia Mills.

3. The distribution system extending from the Whitney Mills to the Town of Cherokee Springs.

4. The distribution system in the vicinity of the Clifton Mills.

5. The distribution system in and about the Town of Wellford, and extending to the Tucapau Mills, of which some of the wires are strung upon transmission line poles or towers from the Jackson Mills to the Tucapau Mills, the said transmission line having been heretofore conveyed to the Duke Power Company.

6. The distribution system in and about the Town of New Prospect, between the Towns of Fingerville and Campobello.

7. The distribution system in and about the Town of Chesnee.

8. The distribution system in and about the Town of Fingerville.

9. The distribution system extending from Gramling to Holly Springs and vicinity.

10. The distribution system in the vicinity of Nesbit's Gin, the wires of which are strung upon transmission line poles or towers heretofore conveyed to the Duke Power Company.

11. That franchise granted by the Town of Inman to the Manufacturers' Power Company June 5, 1913.

12. That franchise granted by the Town of Landrum to the Manufacturers' Power Company March 21, 1913, and that franchise granted by the Town of Landrum to C. P. Rogers and others, March 21, 1913; and the distribution system in and about the Town of Landrum, and extending to Tryon, N. C.

13. That franchise granted by the Town of Duncan to the Manufacturers' Power Company December 8, 1923; and the distribution system in and about the Town of Duncan.

14. That franchise granted by the Town of Campobello to the Manufacturers' Power Company July 15, 1914; and the distribution system in and about the town of Campobello.

15. That franchise granted by the Town of Woodruff to the Blue Ridge Power Company July 14, 1925.

16. That distribution system extending from the Van Patton Shoals to the Town of Crescent.

17. The distribution system in and about the Town of Enoree.

Being the same property described in deed from Wateree Power Company to the Company, dated June 12, 1929, duly recorded in the

public registry of Spartanburg County, South Carolina, in Book 7-B, at page 418.

**PARCEL NO. 8.**

The following described property, to-wit:

1. That franchise granted by the Town of Greer to the Broad River Power Company February 15, 1927.

2. That franchise granted by the Town of Fountain Inn to the Broad River Power Company, August 9, 1926; and the distribution system in and about the Town of Fountain Inn.

3. That franchise granted by the Town of Simpsonville to the Broad River Power Company in the year 1926.

Being the same property described in deed from Wateree Power Company to the Company, dated June 12, 1929, duly recorded in the public registry of Greenville County, South Carolina, in Book 142, at page 585.

**PARCEL NO. 9.**

The following described electric transmission and distribution lines and systems, franchises and other property located in Laurens County, South Carolina, to-wit:

1. A 6,600 volt, single circuit line, extending from Fountain Inn to Gray Court, 8.50 miles in length.

2. That franchise granted by the Town of Gray Court to the Broad River Power Company August 16, 1926; and the distribution system in and about the Town of Gray Court.

3. That franchise granted by the Town of Laurens to the Blue Ridge Power Company February 20, 1925.

4. The distribution system in and about the Town of Owings.

Being the property described in deed from Wateree Power Company to the Company, dated June 12, 1929, duly recorded in the public registry of Laurens County, South Carolina, in Book 57, at page 202.

The foregoing nine parcels being a part of the property heretofore conveyed by Broad River Power Company to the Wateree Power Company, and being the property heretofore conveyed by the Wateree Power Company to the Company.

**PARCEL NO. 10.**

That lot of land in or near the Town of Matthews, Mecklenburg County, North Carolina, described as follows:
