

It is the intent and purpose of this instrument to convey to the Trustee, its successors and assigns, the entire distribution and lighting plant and system of the Company, including all rights, privileges, and easements owned, exercised and enjoyed, or in anywise accruing to the Company in respect to said electric distribution and lighting system.

And being the same property conveyed to the Company by deed of Town of Wingate, dated November 8th, 1926, duly recorded in the public registry of Union County, North Carolina, in Book 65 at page 243.

**PARCEL NO. 17.**

The electric distribution system and other property in and near the City of North Wilkesboro, described as follows:

The electric distribution and lighting system used and operated by the Company in the City of North Wilkesboro and vicinity, including all personal property constituting said system and used, or held for use, in the operation and maintenance of same.

Being the same property conveyed to the Company by deed of the City of North Wilkesboro, dated May 31st, 1927, duly recorded in the public registry of Wilkes County, North Carolina, in Book 145 at page 116.

**PARCEL NO. 18.**

The electric distribution and lighting system at and near Hiddenite, Loray and Stoney Point in Iredell and Alexander Counties, North Carolina, described as follows:

The electric distribution and lighting system of the Company, located in, near and between the Towns of Hiddenite, Loray and Stoney Point, including all rights-of-way and all the physical property formerly of the Hiddenite Light & Power Company, Inc.

Being the property conveyed to the Company by deed of said Hiddenite Light and Power Company, Inc., dated March 23, 1927, duly recorded in the public registry of Alexander County, North Carolina, in Book 18, at page 47, and in the public registry of Iredell County, North Carolina, in Book 88, at page 90.

**PARCEL NO. 19.**

The electric distribution system in the Town of Madison in Rockingham County, North Carolina, described as follows:

The electric distribution system formerly owned by said Town of Madison and all easements and rights-of-way and personal property constituting said system, and all personal property used or held for use in connection with the operation and maintenance of same, said property being situated in and near the Town of Madison. (It is understood that the Muncie oil engine, the generator and switchboard belonging to the Town of Madison are not included in the property hereby conveyed).

Including all the property conveyed to the Company by deed of the Town of Madison, dated August 1, 1927, duly recorded in the public registry of Rockingham County, North Carolina, in Book 240 at page 414.

**PARCEL NO. 20.**

The electric distribution system in and near the Town of Stoneville in Rockingham County, North Carolina, described as follows:

The electric distribution system of the Company, including all easements and rights-of-way and personal property constituting said system, and all personal property used or held for use in connection with the operation and maintenance of same; said property being situated in and near the Town of Stoneville. (It is understood that the Fairbanks-Moss oil engine, the dynamo and switchboard located on the town electric light lot, together with said lot, are not included in the property being sold and conveyed hereby.)

Including all the property conveyed to the Company by deed of the Town of Stoneville, dated August 1st, 1927, duly recorded in the public registry of Rockingham County, North Carolina, in Book 240, at page 414.

The electric distribution system at or near the Town of Troutman in Iredell County, North Carolina, described as follows:

All of the transmission and distribution system of the Company to, in and near the Town of Troutman, including the poles, wires, transformers, meters, apparatus, material, supplies and equipment, and all rights-of-way and easements, and all franchises of the Company, and being in all respects all the property used, or held for use, by the Company, and constituting its electric transmission and distribution system, in and near the Town of Troutman, in Iredell County, North Carolina, and including the transmission line from a point at or near the Iredell County Home to the said Town of Troutman.

Including all the property conveyed to the Company by deed of Troutman Light and Power Company, dated October 31st, 1927, duly recorded in the public registry of Iredell County, North Carolina, in Book 90 at page 308.

**PARCEL NO. 22.**

The electric distribution system at or near the Town of Conover, in Catawba County, North Carolina, described as follows:

The electric light and distribution system and lines of the Company, and all appurtenances, appliances and property used or held for use in connection therewith, as the same is now used or controlled by the Company, including all supplies and other property now held by the Company in connection therewith, and all rights-of-way and easements owned or held by the Company, used or to be used in connection with said lighting and distribution system.

Including all property conveyed to the Company by deed of the Town of Conover, dated December 9th, 1927, duly recorded in the public registry of Catawba County, North Carolina, in Book 196 at page 503.

**PARCEL NO. 23.**

The electric distribution system in and near the Town of Ronda, Wilkes County, North Carolina, described as follows:

All of the electric transmission and distribution system of the Company in and near the Town of Ronda, in the County of Wilkes, State of North Carolina, including all poles, wires, transformers, meters, apparatus, material, supplies and equipment, and all rights-of-way, privileges and easements of the Company in connection with said electric transmission and distribution system.

Including all property conveyed to the Company by deed of Mary Gwyn and Nora Gwyn, dated December 12, 1927, duly recorded in the public registry of Wilkes County, North Carolina, in Book 153 at page 6.

**PARCEL NO. 24.**

The property and electric distribution system in and near the Town of Waxhaw, in Union County, North Carolina, described as follows:

(a) All that certain tract or parcel of land located in the county and state aforesaid, in the Town of Waxhaw, on the waters of Blythe's Creek, adjoining the lands of A. W. Heath Sons, Inc., J. W. McCain, and others and being bounded and described as follows:

**BEGINNING** at an iron stake, the northeast corner of McCain and Carolina Streets, and runs said McCain Street N. 48 E. 50 feet to an iron stake south side of McCain Street; thence N. 42 E. 50 feet to an iron stake; thence S. 48 W. 50 feet to an iron stake east side of Carolina Street; thence with said street N. 42 W. 50 feet to the **BEGINNING**, containing 2500 square feet, this being the lot upon which is located the electric sub-station formerly of the Town of Waxhaw, the said lands being shown in a deed dated March 26, 1925, executed by A. W. Heath Sons, Inc. to the Board of Aldermen of the Town of Waxhaw and registered in Deed Book 66 of the Register of Deeds' Office of Union county, page 88.
