

heirs and others under option agreement dated November 5th, 1928, accepted and paid for by the said Gaston Light and Power Company December 10th, 1928, and by said Gaston Light and Power Company conveyed to the Company.

E. All customer contracts and equipment purchased by the Gaston Light and Power Company for or in connection with the proposed line, extending from the Lindsay & McArver store, on and along the York Road to Ridge Mill, and by said Gaston Light and Power Company conveyed to the Company.

4—All rights of the Company under and by virtue of any and all contracts, agreements and understanding which Gaston Light and Power Company had with the City of Gastonia for the purchase of power, the transfer by the City of electric lines, meters, service and so forth, or otherwise, and by said Gaston Light and Power Company assigned to the Company, together with all property acquired thereunder.

5—Also all property of every nature and description, described in and conveyed to Gaston Light and Power Company under and by virtue of a certain conveyance or contract by Michael & Bivens, Incorporated, dated May 30th, 1928, and by said Gaston Light and Power Company conveyed to the Company.

6—All of the right, title, interest and estate of the Company under and by virtue of two certain contracts by and between the said Gaston Light and Power Company and the North Carolina State Highway Commission one of which is dated July 16th, 1928, and the other of which is dated November 28th, 1928, and by said Gaston Light and Power Company assigned to the Company.

Including all transmission lines, equipment, supplies, rights-of-way, franchises, contracts, and all property of every nature and description constituting the electric distribution, transmission and lighting system, or systems, formerly of said Gaston Light and Power Company, and all property of every nature and description used or held for use in connection with the operation and maintenance of said systems.

Including all property conveyed to the Company by deed of Gaston Light and Power Company, dated January 11th, 1929, duly recorded in the public registry of Gaston County, North Carolina, in Book 242 at page 383.

#### PARCEL NO. 32.

The electric distribution system near the City of Gastonia, in Gaston County, North Carolina, described as follows:

All of the right, title, interest and estate (being a one-half undivided interest) of the Company in and to the electric distribution, transmission and lighting system located in Gaston County along the Union Road to the Fairview Dairy, a distance of approximately two and three-tenths miles, including all poles, wires, cross-arms, insulators, and also including all rights-of-way used or held for use in connection with the maintenance and operation of said line.

Being all of the property conveyed to the Company by deed of Union Development Company, dated February 22, 1929, recorded in the public registry of Gaston County, North Carolina, in Book 242, at page 504.

#### PARCEL NO. 33.

The electric transmission line near the City of Gastonia in Gaston County, North Carolina, described as follows:

The electric distribution, transmission and lighting system belonging to the Company, located on Lindwood Road at or near Gastonia, and extending from the City limits on Lindwood Street along the Lindwood Road, a distance of approximately six-tenths (6/10) of a mile, and including all poles, wires, crossarms, insulators, and other apparatus and appliances, and also all rights-of-way used or held for use in connection with the maintenance and operation of said line.

Including all of the property conveyed to the Company by deed of N. G. Cloninger and M. B. Cloninger, dated February 25th, 1929, duly recorded in the public registry of Gaston County, North Carolina, in Book 242, at page 505.

#### PARCEL NO. 34.

The electric distribution system and other property at or near the Town of Mooresville, Iredell County, North Carolina, described as follows:

(a) The electric distribution, transmission and lighting system formerly of the Town of Mooresville, located in and near said Town, including all electric lines, poles, towers, cross-arms, insulators, transformers, substations, meters, tools and apparatus, appliances, supplies, fixtures and merchandise, and all rights-of-way, privileges, easements, immunities and property of every nature and description constituting said distribution, transmission and lighting system, and all property used or held for use in connection with the construction, maintenance and operation of same; and also including all contracts and rights formerly held by said Town of Mooresville as a part of or in connection with said system.

(b) That lot of land in the Town of Mooresville, Iredell County, N. C., described as follows:

BEGINNING at a stake on the Southeast edge of a 12-foot alley, which stake is N. 45 W. 185 feet from the Southeast corner of the Municipal Building lot of the Town of Mooresville on Broad Street, and running thence from said stake with the line of said alley S. 45 W. 30 feet to a stake; thence S. 45 E. 24 feet to a stake, a new corner; thence a new line N. 45 E. 30 feet to a stake in the line of the lot hereinafter mentioned; thence with said line N. 45 W. 24 feet to the BEGINNING, and being a part of the lot conveyed to the Town of Mooresville by deed of W. M. Freeze and wife, dated November 8, 1922, recorded in the office of the Register of Deeds of Iredell County in Book 71 at page 359, and being the lot upon which is located the electric substation formerly of the Town of Mooresville;

Together with the right to the use of the above mentioned 12-foot alleyway for ingress, egress and regress to and from the above described lot; and, also, all buildings, structures, poles, wires, towers, transformers, meters, tools, supplies, fixtures, and all property of every nature and description located upon said property.

(c) The electric transmission line extending from the Town of Mooresville to the water works pumping station of said Town, including such rights-of-way and easements as are necessary and/or useful in the maintenance and operation of same.

It is the intent and purpose of this instrument to convey to the Trustee, its successors and assigns, the entire electric distribution, transmission and lighting plant and system of the Company in and around the Town of Mooresville, including all rights, privileges, easements, contracts and immunities owned, exercised and enjoyed by or in anywise accruing to the Company in respect to said system.

Being all of the property conveyed to the Company by deed of the Town of Mooresville, dated April 1st, 1929, duly recorded in the public registry of Iredell County, North Carolina, in Book 95 at page 511.

#### PARCEL NO. 35.

The hydroelectric plant, transmission and distribution system located at and near Mt. Airy, in Surry County, North Carolina, described as follows:

(A) All those certain tracts or parcels of land lying and being in Mt. Airy Township, County and State aforesaid, and more particularly bounded and described as follows:

1. That certain lot situate in the Town of Mt. Airy on the North side of Oak Street, BEGINNING at a stake set in the edge of Oak Street 19 feet from the Southeast corner of R. W. Watson's Leaf House, formerly known as Prather and Whitlock's Factory, and running with Oak Street N. 65-30 E. 46 feet to a stake in the edge of said Street; thence N. 20-41 W. 96½ feet to a stake; thence S. 60-30 W. 46 feet to a stake; thence S. 25-30 E. 96½ feet to the BEGINNING, and being in all respects the same lot conveyed to the said Town of Mt. Airy by R. W. Watson and wife, by deed dated March 3, 1914, and recorded in Book 64, Page 545.

2. Lying on the East bank of the Ararat River, BEGINNING 12 feet South from a Beech tree, corner between Terrell and Roberts lands; and running thence down the River as follows: N. 74-30 W. 80 feet; N. 73 W. 225 feet; N. 63-40 W. 200 feet; thence leaving the River S. 5-30
