

taining acres, more or less, and being in all respects the same land conveyed to the Town of Mount Airy by J. E. Davis by deed dated June 19, 1918, and recorded in Book 76, page 223, and by the said Town of Mount Airy conveyed to John Mabe by deed dated December 13, 1919, and recorded in Book 81, page 77, out of which said last conveyance the aforesaid rights, privileges and easements were reserved unto the said Town of Mount Airy.

2. BEGINNING at a Double Birch on the South side of the Buck Shoals road on the East bank of a branch; and running thence down the branch as it meanders about S. 7½ W. 300 feet to the East bank of Ararat River; thence down the river as it meanders 1596 feet, more or less, to a large White Oak; thence leaving the river S. 68¼ E. 133 feet to a Pine; thence N. 7½ E. 124 feet to a Walnut; thence N. 6½ W. 66 feet; thence N. 14½ E. 82 feet; thence N. 27½ E. 209 feet to a Pine; thence N. 40½ E. 327 feet; thence N. 32½ E. 147 feet; thence N. 39½ E. 108 feet; thence N. 46 E. 101 feet; thence N. 38½ E. 306 feet; thence N. 47½ E. 170 feet to a stake marked by pointers in I. J. Simmons' line; thence with his line N. 35¼ E. 225 feet; thence leaving his line N. 58¼ W. 1474 feet to a stake in the middle of the present Buck Shoals road; thence about with the road as it meanders S. 43½ W. 100 feet; S. 34½ W. 100 feet; S. 49 W. 200 feet; S. 50¼ W. 318 feet; S. 36½ W. 267 feet to a Pine on the South side of said road; thence S. 65½ W. 336 feet to the BEGINNING, containing 59.38 acres, more or less, and being a part of the land conveyed to the said Town of Mount Airy by Pulaski Cowper, and others, by deed dated February 8, 1901, and recorded in Book 39, page 37, and being the same land conveyed by the Town of Mount Airy to Penn Brannock, by deed dated February 18, 1916, and recorded in Book 70, page 218, out of which said last conveyance the aforesaid rights, privileges, and easements were reserved unto the said Town of Mount Airy.

3. BEGINNING at a stake between two springs in the line between James Greenwood and Isaac Armfield, and running thence S. 69 E. 2.93 chains to a stake in the road; thence with the road S. 7 2 chains to a stake; thence with the road S. 18 W. 5 chains to the old Ridge road; thence N. 70 W. 1.20 chains to the old line; thence North along the old line to the BEGINNING, containing 1½ acres, more or less.

Also another tract, BEGINNING at a Sourwood near a large Poplar, marked as a corner, and running thence East by said Poplar 34.50 chains; thence S. 71 E. 3.16 chains; thence up the branch S. 46 E. 3.77 chains to two springs; thence S. 8 chains to a White Oak on the South side of the old Ridge road; thence S. 42 W. 12 chains to a Chestnut on the South side of said road; thence S. 71 W. 5 chains to a Black Oak in the fork of the road; thence N. 78 W. 10.50 chains along said road to a Post Oak; thence N. 70 W. 9.50 chains to a Spanish Oak on the North side of said road; thence West along the road 3 chains to a Chestnut Sapling on the South side of said road; thence N. 17 W. 16.25 chains to the BEGINNING, containing 68½ acres, more or less.

The above two tracts of land being the same lands conveyed to Susan Jones by James Greenwood and wife by deed dated January 14, 1881, and recorded in Book 19, page 184, and upon which the aforesaid rights, privileges, and easements were awarded to the Town of Mount Airy by judgment of Superior Court, recorded in Minute Docket No. 10, page 112.

4. That tract of land known as the Wilcher Banner 200 Acre Home Tract, lying North of and between Lovell's Creek and the Ararat River, and bounded on the North by the corporate limits of the Town of Mount Airy, upon which said tract of land the aforesaid rights, privileges and easements were awarded to the Town of Mount Airy by judgment of Superior Court, recorded in Minute Book No. 10, page 294.

5. BEGINNING at a Dogwood, W. G. Foy's corner, in Haynes' line, and running thence S. 87 E. 2.20 chains to a Black Oak; N. 84 E. 25.20 chains to a Black Gum, W. D. Haynes' corner; N. 53 W. 3.60 chains to a stake and pointers; N. 83 E. 3 chains to the mouth of a culvert at the Railroad; N. 83 E. 6 chains to Lovell's Creek; thence up the creek as it meanders to the ford on the Rockford and Dobson road; thence continuing a short distance up the creek to a point where formerly stood a Birch on the Northeast bank of said creek, Foy's and Hollingsworth's corner; thence S. 22 W. 3.50 chains crossing the creek to the East bank of the Rockford and Dobson road; thence S. 60½ W. 3.40 chains to a post on top of the railroad's right-of-way; thence S. 19 W. 4 chains to a stake in the old road; thence with the South side of the old road S. 9¼ E. 5 chains to a stake; thence with the said old road S. 61 W. 4 chains to a stake; thence with the said road S. 72 W.

3.55 chains to a stake; thence S. 64 W. 3 chains to a stake on the West side of the new road; thence with the new road S. 15¼ W. 12.30 chains to a stake near the intersection of the McKinney and Greenwood road with the Dobson road; thence with the McKinney and Greenwood road S. 11 W. 3 chains; S. 8½ W. 5 chains; and S. 11½ W. 10.50 chains to the BEGINNING, containing acres, more or less, and being the same land conveyed to M. C. Reeves by W. F. Carter, Commissioner, by deed dated June 22, 1906, and recorded in Book 47, page 340, and upon which the aforesaid rights, privileges and easements were awarded to the Town of Mount Airy by judgment of Superior Court, recorded in Minute Book No. 10, page 253.

6. BEGINNING on the bank of the Ararat River in the mouth of Seed Cave Creek; and running up the said creek as it meanders 8 chains to the mouth of Ash Spring branch; thence S. 2½ W. to the old Gettings' line; thence with said line West to the Ararat River; thence up the said river as it meanders to the BEGINNING, containing acres, more or less, and being the same land conveyed to Anne R. Moore and others by E. F. Hollingsworth and wife by deed dated January 6, 1897, and recorded in Book 32, page 283, and upon which the aforesaid rights, privileges, and easements were awarded to the Town of Mount Airy by judgment of Superior Court, recorded in Minute Book No. 11, page 304.

7. BEGINNING at a White Oak stump on the North bank of Stewart's Creek at the railroad bridge, and running up said creek as it meanders to a small Birch tree 66 feet above the mouth of the first ditch; thence N. 53½ W. 1177 feet parallel with and 90 feet South of the main line of said ditch to a planted rock at the foot of the hill; thence N. 35 E. 85 feet to the middle of the branch; thence up the said branch to the first fork; thence up the North fork of said branch about 150 feet to a bunch of willows; thence N. 49 E. 548 feet to an Apple Tree; thence N. 11 W. 320 feet to a Red Oak tree; thence N. 44½ W. 522 feet to a Red Oak stump; thence W. 500 feet to a stake and pointers in a road; thence N. 25 W. 570 feet to the middle of a road, Black Oak and Holly pointers; thence with said road S. 83 E. 447 feet; thence with an old road S. 64 E. 400 feet; thence S. 56 E. 770 feet to an old corner; thence S. 81 E. 450 feet; thence S. 83 E. 235 feet to a large Red Oak, partly torn down; thence S. 36½ E. 238 feet to an old gate; thence S. 19 E. 1400 feet to an old Apple Tree; thence S. 37½ E. 1177 feet, more or less, to the BEGINNING, containing 94 acres, more or less, and being the same land conveyed to the Town of Mount Airy by W. G. Sydnor and wife by deed dated July 21, 1903, and recorded in Book , page , and by the Town of Mount Airy conveyed to W. A. Lawrence by deed dated November 2, 1904, and recorded in Book 43, page 423, out of which said last conveyance the aforesaid rights, privileges, and easements were excepted and reserved unto the said Town of Mount Airy.

8. That tract of land containing 139½ acres, more or less, and particularly described in a deed made by W. D. Haynes and others to C. H. Haynes dated January 14, 1890, and recorded in Book 26, page 261.

9. That tract of land containing 67½ acres, more or less, and particularly described in deeds made by C. W. Bunker and wife to W. D. Haynes, dated August 10, 1891, and recorded in Book 27, page 260, and by C. H. Haynes to W. D. Haynes, dated April 19, 1887, and recorded in Book 27, page 261.

10. That tract of land containing 75 acres, more or less, and particularly described in a deed made by W. A. Boone and others to Ada E. York, dated January 6, 1893, and recorded in Book 28, page 362.

11. BEGINNING at a stake in a branch, which is the line between the lands of Miss Ella Greenwood and the old Greenwood Home Place, and running thence S. 77-30 W. 300 feet to a stake 2 feet beyond a triple Dogwood stump 4 feet high; thence S. 83-45 400 feet to a stake on the East side of a road; thence with the road S. 49 E. 225 feet to a planted rock at the foot of the hill; thence S. 11 E. 420 feet; thence S. 213 feet; thence S. 79 E. 847 feet to the bank of Stewart's Creek at a point 20 feet above the mouth of the middle ditch; thence down the said creek as it meanders to a small Birch Tree 66 feet above the mouth of the lower ditch; thence N. 53-30 W. 1177 feet parallel with and 90 feet South of the main line of said ditch to a planted rock at the foot of the hill; thence N. 35 E. 85 feet to the middle of a branch; thence up the branch as it meanders N. 33 W. 126 feet to the BEGINNING, containing acres, more or less, and being the same lands conveyed to the Town of Mount Airy by Ella Greenwood by deed dated
