WHEREAS, it has been represented to City Bank Farmers Trust Company as Trustee that the Southern Power Company later conveyed to the Duke Power Company, a corporation duly organized and existing under and by virtue of the laws of the State of New Jersey, the properties mentioned and described in the above mentioned mortgages, that and said Duke Power Company is, at the date of this indenture, the owner of all of the said properties mentioned and described in said mortgages; and

WHEREAS, all of the bonds duly issued under the said mortgage and secured by said mortgage and supplemental mortgages have been paid and redeemed or otherwise accounted for as in the said mortgage is provided, and all other obligations arising under the said mortgage have been fully and faithfully performed; and

WHEREAS, the corporate name of the Farmers' Loan and Trust Company has heretofore been duly changed to City Bank Farmers' Trust Company, and City Bank Farmers Trust Company is the corporation formerly known as The Farmers' Loan and Trust Company, and is the corporation to which the Southern Power Company executed and delivered the above mentioned first mortgage and supplemental mortgages.

Now, therefore, in consideration of the premises, and of the full performance of the said obligations, the said City Bank Farmers' Trust Company, Trustee in the aforesaid mortgage and supplemental mortgages, hereby accepts the satisfaction of the same, and hereby releases and discharges the properties mentioned and described in the said mortgage and supplemental mortgages from the lien and operation of same, and the said City Bank Farmers' Trust Company hereby remises, releases and forever quitclaims unto the said Duke Power Company, its successors and assigns, all of its right, title, interest, estate, claim and demand in, to, or upon any and all of the properties mentioned and described in the said mortgage and supplemental mortgages; and the said City Bank Farmers' Trust Company, as such Trustee, hereby authorizes, empowers and directs the Registers of Deeds and/or Clerks of Court and/or registers of Mesne Conveyances of the Counties above mentioned and referred to, to enter upon the record of the said mortgage and supplemental mortgages of their respective counties a full satisfaction and cancellation of the same.

In order to facilitate the recording of this instrument, the same may be simultaneously executed in ten counterparts, each of which so executed shall be deemed to be an original, and such counterparts together shall constitute and be one and the same instrument.

In witness whereof, the said City Bank Farmers' Trust Company has caused these presents to be duly signed in its name and behalf, and its corporate seal to be hereto affixed by its proper officers, all by authority of its Board of directors duly given, this the day and year first above written.
