SEND GREETING:

WHEREAS, **I**, the said **H. W. Chiles**,  
in and by **my** certain **obligation or** note, in writing, of  
even date with these presents, **am** well and truly indebted to

**A. K. Park**  
in the full and just sum of **Three hundred and fifty (\$350.00)**  
Dollars, to be paid **one year after date thereof**

with interest thereon, from **date** the date of **8** per cent. per annum to be  
computed and paid **annually**

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing of an attorney's fee of

**ten per cent on said amount** besides the costs and expenses of collection, to be  
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That **I** the said **H. W. Chiles**,  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
**A. K. Park**

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to **me**, the said  
**H. W. Chiles**,

in hand well and truly paid by the said **A. K. Park**

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-  
gain, sell and release unto the said **A. K. Park, his heirs and assigns.**

All that certain piece, parcel or tract of land situate, lying and being in the  
State of South Carolina, and County of Greenville, in Gantt Township, about seven miles  
South of Greenville Court House, and having the following metes and bounds, to wit:

Beginning at a stone 3xe in Paper Mill Road, corner of land of M. Page and running  
thence with said Road N. 77½ E. 3.00 chs. to a bend in said Road; thence N. 83 E. 7.20 chs.  
to a stone at corner of land of Mrs. Lizzie Cox; thence N. 15½ W. 11.94 chs. to a stone  
3xem; thence S. 3¼ E. 6.58 chs. to the beginning corner, and containing ten and one half  
(10½) acres, more or less, this being the same land conveyed to me said H. W. Chiles by  
H. C. Wood by deed, dated 10th day of January A. D. 1918 and recorded in the R. M. C.
