NOW, KNOW ALL MEN, That I, the said *Otis P. Mills*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Jeannette P. Miller*

all that tract or lot of land in *Greenville* Township, Greenville County, State of South Carolina.

Known and designated as lot No. 2, Block 2, on plat of property of O. P. Mills recorded in R. M. C. office for said County in plat book 2, page 171, having the following metes and bounds: Beginning at an iron pipe on the south side of Prentiss Avenue, 188 feet from the southwest corner of Church Street and Prentiss Avenue, thence along line of lot No. 3 S. 44-33 E. 180 feet to an iron pipe on rear line; thence along rear line N. 45-27 E. 28.5 feet to pipe on west side of Church Street; thence along west side of Church N. 0-40 E. 51.3 feet to an iron pipe at corner of lot No. 1; thence along line of lot No. 1, N. 44-33 W. 143.5 feet to an iron pipe on the south side of Prentiss Avenue; thence along the south side of Prentiss Avenue S. 45-27 W. 62 feet to beginning.

Also that other lot of land in township, County and state aforesaid, known as lot No. 13, Block 2, as shown on above mentioned plat, having a frontage on Mills Avenue of 60 feet, with a depth of 180 feet.

Also that other lot of land in township, County and state aforesaid, known as lot No. 16, Block 2, as shown on above mentioned plat, having a frontage of 62 feet on Prentiss Avenue, with a depth of 180 feet.

Also that other lot of land in township, County and state aforesaid, known as lot No. 22 Block 2, as shown on above mentioned plat, fronting 63 feet on Prentiss Avenue, with a depth of 168 feet.
