until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Heirs, Executors, Administrators and Assigns:-
All that certain piece, parcel or strip of land situate, lying and being in Paris Mountain Township, between the Paris Mountain Road, as now located, and the right of way of the new Buncombe Road, also known as U.S. Highway No. 25, leading from Greenville to Travelers Rest, S. C., said strip being shown as lot No. 5 on plat of the property of Greenville County made March 15th, 1932, by Jack Wier, C. E., said plat to be recorded in the R. M. C. office for Greenville County in Plat Book "D", at page 161, and being more particularly described on said plat as follows:

Beginning at an iron pin on the Western side of U.S. Highway No. 25, leading from Greenville to Travelers Rest, S.C., at the joint corner of lots Nos. 4 and 5, and running thence in a Northerly direction along the Western side of said Highway 140 feet more or less to an iron pin on said Highway at the corner of lots Nos. 5 and 6 on said plat; thence along line of said lots in a Westerly direction 34 feet more or less, to an iron pin on the East side of Paris Mountain Road; thence along the East side of said Road in a Southerly direction to an iron pin at the joint corner of lots Nos. 4 and 5; thence along the joint line of said lots in an Easterly direction 30 feet more or less to the beginning corner.
