

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

I do hereby bind myself and my Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Fred H. PROVIDED ALWAYS, nevertheless, and that it is the true intent and meaning of the parties to these Presents, that if _____, the said mortgagor _____, do and shall well and truly pay or cause to be paid unto the said mortgagee _____ the debt or sum of money aforesaid, with interest thereon, if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void; otherwise to remain in full force and virtue.
