I do hereby bind *myself and my* Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said *Mrs. J. H. Alewine, A. W. Alewine and Ansel Alewine a partnership trading as Taylors Lumber Company their* Heirs and Assigns, from and against *myself and my* Heirs, Executors, Administrators and Assigns and every person whomsoever lawfully claiming or to claim the same or any part thereof.

And the said mortgagor _____ agree _____ to insure the house and buildings on said lot in a sum not less than *Four Hundred (\$400.00)* Dollars, in a company or companies satisfactory to the mortgagee *S* and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee *S*; and that in the event that the mortgagor _____ shall at any time fail to do so, then the said mortgagee _____ may cause the same to be insured in *his* name and reimburse *themselves* for the premium and expense of such insurance under this mortgage, with interest.
