according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said **J. J. Robinson 35** shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at **Greenville, S.C.** on the 20th or before the end of the month of **November**

being the monthly interest on balance due); for the next twenty months pay the sum of

Three and 50/100 (\$3.50) Dollars, (**Ten (\$10.00)**
Dollars, being the monthly installment on said shares of stock and **Three and 50/100 (\$3.50)** Dollars,
being the monthly interest on balance due); for the next twenty months pay the sum of

Twelve and 33/100 (\$12.33) Dollars, (**Ten (\$10.00)**
Dollars, being the monthly installment on said shares of stock and **Twelve and 33/100 (\$12.33)** Dollars,
being the monthly interest on balance due); for the next twenty months pay the sum of

Eleven and 17/100 (\$11.17) Dollars, (**Ten (\$10.00)**
Dollars, being the monthly installment on said shares of stock and **One and 17/100 (\$1.17)** Dollars,

"E", of Sterling Annex, a revised and correct plat of which is recorded in Plat Book
"E", page 141, and conveyed to me by Thomas F. Parker, deed dated October 8, 1914,
recorded in Deed Book 39, page 309.

Also: All that lot in the City of Greenville, on Nichols Street, and having
the following metes and bounds, to-wit:

Beginning at corner of Lot #3; thence S. 28 W. 1.90 chs.; thence E. 67 1/2 E. 1.25
chs.; thence N. 28 E. 2.48 chs.; thence N. 73 1/2 W. 1.25 chs. to the beginning corner,
being Lot #2 of the Slean land, and being the same lot conveyed to me by S. W. Seawright,
by deed dated August 2, 1919.
