WHEREAS *H. H. Lowmyer*, the said *H. H. Lowmyer*, in and by *H. H. Lowmyer* certain note or obligation, bearing date the *9th* day of *July* 19 *31*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *One Thousand (\$1,000.00)* Dollars, with interest thereon at the rate of *seven* per centum per annum, payable monthly from the *9th* day of *July* A. D. 19 *31* according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *H. H. Lowmyer*

the said *H. H. Lowmyer* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *August* 19 *31*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Fifteen (\$15.00)* Dollars, *10.00* Dollars, being the regular monthly installment payable on the

ten Shares of Stock and *Five (\$5.00)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Fifteen (\$15.00)* Dollars, (*4.67*) Dollars, being the regular monthly payment on said stock and *Four (\$4.00)* Dollars, being the monthly interest on balance due; for the next twenty months the sum of *Twenty (\$20.00)* Dollars, being the regular monthly payment on said stock and *Five (\$5.00)* Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of *Twenty (\$20.00)* Dollars, being the monthly installment on said shares of stock and *Three (\$3.00)* Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of *Eleven (\$11.00)* Dollars, being the monthly payment on said shares of stock and *One (\$1.00)* Dollars, being the monthly interest on balance due; Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *ten* shares of stock and the certificate therefor, the amount at such time paid shares by *H. in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

in the City of Greenville, having the following Metes and Bounds to wit:
Beginning at the corner of C. J. J. Giles Lot on Pendleton Street, and thence running S. 89-17 W. 109 feet; thence S. 10-50 W. 50.2 feet to Earley Street; thence with Earley Street S. 55-01 W. 67 feet; thence N. 2-20 W. 75 feet; thence N. 2-30 E. 147.7 feet to Pendleton Street; thence with Pendleton Street S. 63-32 E. 56 feet to the beginning corner, and being the same lot which was conveyed to me, the said *H. H. Lowmyer*, by *J. B. Scruggs*, by deed dated August 29, 1921, recorded in Deed Book 58, Page 194, in the R. M. C. office for said Greenville County.
