AND IT IS AGREED, by and between the said parties, that the said R. F. Lopper, his

heirs, executors, administrators or assigns, shall and will forthwith insure the house and buildings on the said lot, and keep the same insured to the amount of

from damage or loss by fire during the continuance of this mortgage, and assign the policy of insurance to the said The Carolina Loan and Trust Company, its successors or assigns; and that in case the said R. F. Lopper, his heirs, executors, administrators, or assigns, shall at any time fail or neglect or refuse to do so, then, the said The Carolina Loan and Trust Company, its successors or assigns, may cause the same to be insured in its, their, his or her own name, and reimburse itself, themselves, himself or herself hereunder for the premium and expense of insurance, with interest thereon at the rate of eight per centum per annum.

AND IT IS FURTHER AGREED, by and between the said parties, that the said R. F. Lopper, his

heirs, executors, administrators, or assigns shall and will at all times hereafter during the continuance of this mortgage, pay and discharge all taxes and assessments upon the said Premises whenever the same shall become due and payable; and that in case the said R. F. Lopper, his

heirs, executors, administrators or assigns, shall at any time fail or neglect or refuse to pay and discharge the same, then the said The Carolina Loan and Trust Company, its successors or assigns, may pay and discharge the same, and reimburse itself, themselves, himself or herself hereunder therefor, with interest at eight per centum per annum.

AND IT IS EXPRESSLY AGREED AND STIPULATED, that in case the said

R. F. Lopper, his heirs, executors, administrators or assigns, shall fail or neglect or refuse to pay or cause to be paid the aforesaid monthly sums of money as hereinbefore stated, or any part thereof, for a period of Four Months after the same shall become due and payable as aforesaid, or to pay or cause to be paid such fines as may be duly imposed or charged as aforesaid for a like period, or to stand to and abide by the said Charter, By-Laws, Rules and Regulations as aforesaid, or shall fail or neglect or refuse to insure or keep insured the house and buildings on said lot, or to assign the policy of insurance as aforesaid, or to pay and discharge all taxes and assessments on the said Premises as aforesaid, before the expiration of the time fixed by law for the payment thereof, then, in any or all of such cases, at the option of the said Company, the whole indebtedness evidenced by the said note or obligation (including any insurance premiums, and taxes, due and unpaid or paid by the said Company), shall forthwith become and be due and collectible, and the right thereupon exist to foreclose this mortgage therefor, and also for all costs and expenses of such collection, including ten per centum of the amount due under this mortgage and the accompanying note, as attorney's fees.
