# The State of South Carolina,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Whereas Mrs. Raleigh S. Burchett, Committee of Raleigh S. Burchett, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, the said Mrs. Raleigh S. Burchett, Committee of Raleigh S. Lying in State Township, adjoining lands now or formerly of C. C. Good, Southern W. W., W. B. Freeman, E. W. Cochran, and G. A. Ellis, and containing ten acres, more or less, according to a survey made by J. W. Southern, on October 1, 1916, and having the following sides and bounds, according to plat of property made by C. W. Furman, Jr., Engineer, in March, 1931:

Beginning at an iron pin on the road leading from Greenville, S. C. to Piedmont, S. C., joint corner of property now owned by F. L. Carter, formerly owned by C. C. Good, and running thence S. 70-40 E. 17 Chains to an iron pin on what is now or formerly G. A. Ellis's line; thence N. 22-45 E. 8.10 Chains to an iron pin; thence to an iron pin; thence N. 15-30 W. 6 Chains to an iron pin; thence with said Greenville Piedmont Highway S. 1-15 W. 12 Chains to the beginning corner.

Also: all that other piece, parcel or strip of land 16 feet wide, beginning at the corner of the land of G. A. Ellis and land of Mrs. L. W. Cochran on the White Horse Road, said corner being the front of the house now or formerly owned by Dr. W. B. French and at which stands a power line pole; said strip of land to run parallel with the line of G. A. Ellis and Mrs. L. W. Cochran land, and to extend to the property above described. This being the same strip of land conveyed to W. H. Green by G. A. Ellis by deed dated December 30, 1924, recorded in Volume 96, page 292, W. M. C. office for Greenville County, and this being the same land which was conveyed to Mrs. Raleigh S. Burchett, Committee of Raleigh S. Burchett, by W. H. Green March 16, 1931, by deed recorded in the said W. M. C. office for Greenville County in Deed Book 162, page 8.
