of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, Grover C. Harris, the said Grover C. Harris,
 in and by Grover C. Harris certain note or obligation, bearing date the 15th day of May, 1933,
 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly
 incorporated under the laws of such State), in the sum of Fifteen Hundred (\$1500.00) Dollars,
 with interest thereon at the rate of eight per centum per annum, payable monthly from the 15th day of May, A. D. 1933,
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
 the said Grover C. Harris shall pay or cause to be paid to the said
 Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May,
 1933, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty five (\$25.00)
Fifteen Dollars, (\$15.00 Dollars, being the regular monthly installment payable on the
 Shares of Stock and Ten (\$10.00) Dollars,
 being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of
Twenty Three (\$23.00) Dollars, (\$15.00 Dollars, being the regular monthly payment on said stock and
Eight (\$8.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty one (\$21.00) Dollars,
 (\$15.00 Dollars, being the regular monthly payment on said stock and Six (\$6.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of
Four (\$4.00) Dollars, (\$15.00 Dollars, being the monthly installment on said shares of stock and
Seventeen (\$17.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the
 monthly payment on said shares of stock and Two (\$2.00) Dollars, being the monthly interest on balance due); Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company
 the said 15 shares of stock and the certificate thereon, the amount at such time paid shares by
 credited as a payment upon the advance or loan made me, the said Grover C. Harris,
 and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me, the said
Grover C. Harris in accordance with the Charter, By-Laws, Rules and Regulations, as in
 and by the said note or obligation, and the condition thereunder written reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That Grover C. Harris, the said Grover C. Harris,
 in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to
 the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Grover C. Harris
 in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged),
 have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel
 of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, having the following lot 34
 and bounds, to-wit:
 Beginning on the North side of Rhett Street, 45 feet from
 the corner of Rhett Street and Watson Avenue; thence N.
 187.100.5 feet to a pin; thence S 71 W. 45 feet to east side
 of Watson Avenue; thence with Watson Avenue S 18 E.
 100.5 feet to corner of Rhett Street and Watson Avenue;
 thence along north side of Rhett Street N. 71 E. 45 feet to
 the beginning corner.
 This lot is the same conveyed to me, Grover C. Harris,
 by W. B. Watson by deed dated July 2, 1919, and recorded
 in Deed Book 69, at page 167, and a part of the lot or strip
 of land conveyed to me, the said Grover C. Harris, by
