

The State of South Carolina,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. B. Bryant  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, I, the said W. B. Bryant  
in and by my certain note or obligation, bearing date the 4th day of August 1933  
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two Hundred Fifty (\$250.00) Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly from the 4th day of August A. D. 1933  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
I, the said W. B. Bryant shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1933, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Four and 1/100 (\$4.17) Dollars, 2.50 Dollars, being the regular monthly installment payable on the two and one-half Shares of Stock and Over x 67/100 (\$1.67) Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Three and 3/100 (\$3.83) Dollars, (2.50) Dollars, being the regular monthly payment on said stock and Over x 33/100 (\$1.33) Dollars, being the monthly interest on balance due; for the next twenty months the sum of Three and 5/100 (\$3.50) Dollars, (2.50) Dollars, being the regular monthly payment on said stock and Over x 7/100 (\$1.00) Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of Three x 17/100 (\$3.17) Dollars, (2.50) Dollars, being the monthly installment on said shares of stock and Sixty seven cents (\$0.67) Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of Two x 3/100 (\$2.83) Dollars, (2.50) Dollars, being the monthly payment on said shares of stock and thirty three cents (\$0.33) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 2 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said W. B. Bryant and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me, the said W. B. Bryant in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said W. B. Bryant in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said W. B. Bryant

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Lot near the City of Greenville, designated as lot no 34, Block 1, in Newland, and having the following metes and bounds, to-wit:

Beginning at a stake on Charles Street, and running thence S. 43-12 W. 50 feet along Charles Street to a stake, being at the corner of lots nos 34 and 35; thence N. 46-48 W. 150 feet to a stake at corner of lots nos 34 and 35; thence N. 43-12 E. 50 feet to a stake at corner of lots nos 33 and 34; thence S. 46-48 E. to the beginning corner, and shown on plat of A. S. Bedell, Surveyor, of Newland, recorded in Plat Book C, at page 194, and being the same land conveyed to W. B. Bryant by A. G. New, August 22, 1928 and recorded in Deed Book 127 page 180, R.M.C. Office for Greenville County.
