And the said Mortgagor we agree to insure the house and buildings on said lot in a sum not less than Three Thousand
(\$3,000.00) Dollars (in a company or companies satisfactory to the mortgagee), and keep the same insured from loss or damage
by fire, and assign the policy of insurance to said Mortgagee, and that in the event that the mortgagee shall at any time fail to do so, then the said mortgagee may
