SEND GREETING:

WHEREAS, *I*, the said *H. C. Sanders*,in and by *my* certain *Promissory note* in writing, of even date with these presents, *Ann*,*H. C. Richardson*in the full and just sum of *One hundred fifty & No 100 Dollars*, to be paid *\$ 25.00* each consecutive month hereafter until paid in full; should payments not be made when due, this mortgage may become due at the option of the holder thereof and payable in *full*,with interest thereon, from *date* *1st April 1936*, at the rate of *8 1/2 per cent.* per annum to be computed and paid *semi-annually*.until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten percent*

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, the same being placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, in Greenville Township, just off of the Augusta Road, and being lot No. 2 on plat of Willie S. & R. C. B. Martin, and K. E. Mealy as recorded in R. M. C. Office for Greenville County in Plat Book "G" at Page 246, and having the following metes and bounds:

Beginning at the joint corner of lots Nos. 1 and 2 on Sevier Street, and running thence S. 57-20 E. 152.3 feet to iron pipe; thence S. 21-23 W. 61.17 feet to iron pipe at corner of lots Nos. 2 and 3; thence along joint lines of lots 2 and 3 N. 57-20 W. 164.2 feet to iron pipe on Sevier Street; thence along said Street N. 32-40 E. sixty feet to the beginning point.
