And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than Two thousand (\$2,000.00)

Dollars (in a company or companies satisfactory to the mortgagee...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee... and that in the event that the mortgagee... shall at any time fail to do so, then the said mortgagee... may

cause the same to be insured in her name and reimburse her

for the premium and expenses of such insurance under this mortgage, with interest

And if at any time any part of said debt, or interest thereon be past due and unpaid we hereby assign the rents and profits of
