WHEREAS, I, **M. S. Stribling,**  
in and by **my** certain **X** note in writing, of  
even date with these presents, I am well and truly indebted to

in the full and just sum of **One thousand dollars**  
Dollars, to be paid **one year from date**

with interest thereon, from **date** **annually** at the rate of **7** per cent. per annum to be  
computed and paid.

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
rue thereon and foreclose this mortgage, said note further providing for an attorney's fee of **10%**

besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will  
more fully appear.

NOW, KNOW ALL MEN That I, **M. S. Stribling,**  
in consideration of the said **note** and sum of money aforesaid, and for the better securing the payment thereof to the said **Alfred Whitmire,**

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to **me**, the said  
**M. S. Stribling,**

in hand well and truly paid by the said **Alfred Whitmire.**

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell  
and release unto the said **Alfred Whitmire: his heirs and assigns:**

All that lot of land in the County of Greenville, City of Greenville, Beginning  
at an iron pin on Neal Street on the side of a 14 foot alley, and running thence along  
said alley S. 14 W. 110 feet to an iron pin; thence along 10 foot alley S. 76 E. 45 feet  
to an iron pin, joint corner of lots 9½ and 8½; thence along line common to lots Nos. 9½  
and 8½ N. 18½ E. 110.04 feet to an iron pin on Neal Street; thence with said Neal Street  
52 feet to an iron pin, the beginning corner. Being the same lot of land conveyed to me
