All of Lot number One (1) in Block, N. on the West side of
Third Avenue, Park Place containing 50 feet front and 150
feet back and 150 feet deep, and its a part of the tract
of land which was sold and conveyed to J. J. H. Harn,
by deed bearing date of June 6, 1924 and recorded in Vol-
ume 99, Page 348, R.M.C. Office for Greenville County in the State
of South Carolina. Also all of Lot Number (2) in Block, N.
on the West side of Third Avenue containing 50 feet front
and 50 feet back and 150 feet deep, as shown in a re-
vised plat of said Park Place addition on file in R.M.C.
Office for Greenville County in Plat Book or Volume 99,
Page 348. This is the Parcel or tract of land which was
sold and conveyed to me, the said J. J. H. Harn, by deed
from R. L. Quinn bearing date of June 6, 1924. The two
