And the said Mortgagor I agree I to insure the house and buildings on said lot in a sum not less than Seven hundred  
Dollars (in a company or companies satisfactory to the mortgagee.), and keep the same insured from loss or damage  
by fire, and assign the policy of insurance to said Mortgagee his, and that in the event that the mortgagor himself shall at any time fail to do so, then the said mortgagee himself may
