

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. And it is agreed by and between the said parties that the said mortgagor her Heirs, Executors or Administrators, shall and will insure the House and Buildings on said lot in the sum of not less than \$

AND IT IS AGREED by and between the said parties, that in the case of default of payment under any of the conditions of the said Bond, for the space of three consecutive months, it shall be lawful for the said Citizens Building and Loan Association of Greenville County, South Carolina, to begin legal proceedings, or at its option after three weeks publication in one of the newspapers of the city of Greer, to sell the property hereby mortgaged at public auction, and to apply the proceeds of sale to the extinguishment of the debt under this mortgage, and the payment of all costs and expenses, including Attorney's fees, incurred by such sale, and the Bond intended to be secured thereby, returning the overplus, if any, to the said mortgagor, unless the same shall be claimed by a judgment or other mortgage creditor of the said mortgagor, and for the purpose of such sale, the said mortgagor hereby appoints and constitutes the President of the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, and his successors in office, or assigns of said Corporations, or its successors her attorney or attorneys for her and in
